Jeff made a motion to approve the treasurer's report, Andy. made a second. Motion carried.
- B) Clerk: Sent out about 30 absentee ballots, hoping to clean up some of these afterwards, election on February 16. Need to work on the CT Report coming up, but not yet available. Open book is scheduled for April 12, 4-6pm, phone calls only; BOR is scheduled for May 13, 5-7pm, at the Town Hall. I could not find anything that said it had to be a certain percentage for a levy increase, as long as we have a good reason for that increase, and it is approved by the town electors. If we want to set a rule that we do not pay tax overpayments if they are under \$5, we must adopt village powers. Katie will call Wisconsin Towns Assoc. to clarify.

Business:

- A) Andrew Bending CSM: Jeff made a motion to approve CSM as is, Andy made a second. Motion carried.
- B) Zoning changes in Auroraville and south of Hwy 21: Olsen's Mill is looking to change zoning up by the mill to commercial, board is ok with that. Property owner south of 21 out of their conditional permit. Need to figure out how to move forward with that. County wants it to be commercial, not sure that is a good idea for that location.
- C) Berlin North Industrial Park Covenants: The City of Berlin is looking to relax some stipulations so daycares can be built and Northern Express Busing can build sheds for the buses. Town looking into everything as we will have to sign off on this and make sure it does not affect the Town.
- D) Highway Order: To have the road right away, no longer under Town of Aurora, we must create a highway order. We must have a resolution that contains the legal description and scale map, notice the resolution, send to DNR, county, and register of deeds. Notice 30 days before meeting. Calling WTA for further clarification.
- E) Completed Waushara County Natural Hazards Preparedness & Mitigation Questionnaire.

Jeff made a motion to approve the treasurer's report, Andy. made a second. Motion carried.
- B) Clerk: April election saw 122 voters, about 20 being absentee, the board tonight will need to sign their oaths of office, CT report has been completed, records request; told the requestor that payment of \$118 was required up front, have not heard back.

Business:

- A) Alternate BOR member: Need to update our alternater BOR member as Allison is no longer wanting to be a part of it. C.J. made a motion to update the BOR Alternate Member with taking off Allison McCormick and putting on Melissa Zamzow. Andy made a second, motion carried.
- B) Operator's licenses: The operators at Mimi's sent in their applications for their licenses, everything checked out and have been paid for. Andy made a motion to approve all licenses. Jeff made a second. Motion carried.
- C) Road report: 36th Rd quote from county-\$135,000, that is a lot of our road budget with having mowing and possibly snow plowing. Possibly split the 36th Rd project into two years in order to get some other projects done as well. Andy made a motion to fix the culvert on Riverdale for about \$5,000, use \$125,000 to work on 36th Rd with 2 in. of blacktop, spend about \$4,000 in Auroraville for tree trimming and fixing a street sign, roadside mowing and potholes will be about \$10,000, do an overlay on Cypress for about \$5,000, and spend about \$15,000 to seal coat to Cumberland Dr, with some leftover to work with. Jeff made a second. Motion carried.

A motion to approve vouchers was made by Jeff, a second was made by Andy and the motion carried. As no one was at the meeting and there was no further business, the meeting was adjourned at 8:17 p.m.

ANNUAL TOWN MEETING MINUTES APRIL 20, 2021

The annual meeting of the Town of Aurora was held at the town hall on April 20, 2021. Notices of the meeting had been posted at Midway Gas & Oil, Olsen's Mill, and Town Hall board.

The meeting was called to order at 6:37 p. m. by Chairman Young.

The minutes from the 2020 meeting were approved after a motion by Jeff Toll and a second by Jeff Toll. (5 in favor and 0 opposed.) Motion carried.

The 2020 financial report was given by Clerk Reinbold. Copies of the report had been distributed to all electors' present. It was explained that the town had a total of \$77,635.09 available to the town in all accounts on December 31, 2018. Of this amount, \$15,000 is in our contingency, and \$62,6353.09 was undesignated funds. Major expenditures for 2020 included \$122,725 for highway repairs and improvements, \$14,734.25 was spent on elections for wages and upgrading the town hall due to the pandemic. **Jeff Toll made a motion to approve the financial report, C.J. Young made a second.** (5 in favor and 0 opposed.) Motion carried.

The road report was given by Chairman Young. In 2020, the town spent \$18,000 on snow removal, Cypress Ave saw most of the highway budget and there was \$20,000 spent on mowing and a culvert. No action taken.

C.J. Young spoke with Jerry Luttropp and Jerry believes that the town already has village powers. Katie will try to find the resolution for that. Andy Przybyl made a motion to obtain village powers if we do not already have them. C.J. Young made a second. (5 in favor and 0 opposed.) Motion carried.

Discussion of salaries, wages and milage: The mileage rate is the number the state uses which is \$0.56. Road patching is at \$13.50/hour plus mileage, but for this year we are going to use the county. Mowing for the town hall and Sacramento cemetery is \$15/hour (if you use your own mower) plus mileage. Roadside mowing operator will be \$12/hour. Election inspectors are at \$10/hour and chief inspectors are at \$12/hour. Chairman wages are at \$5,000, supervisors are at \$2,750, treasurer is at \$5,000, and clerk is at \$12,000. There was some discussion about the clerk wage going up, but Katie said she is fine where she is at, Andy believes the clerk should have another increase. Jeff mentioned the supervisors having an increase. Jeff Toll made a motion to freeze all wages this year. Melissa Zamzow made a second. (3 in favor and 2 opposed.) Motion carried.

Town posting locations were discussed. Currently the clerk posts notices at Midway Gas, Olsen's Mill, and the Town Hall and on the Town website; www.townaurora.com. Also, the required newspaper notices are being put in the Waushara Argus. A motion to approve keep the posting locations as is was made by C.J. Young with a second by Jeff Toll. Motion passed. (5 in favor and none opposed.)

Beer, wine and liquor licenses were discussed. Liquor license is \$150, beer is \$100, wine is \$100, one day beer license is \$10, and cigarette is \$20. A motion to keep them the same was made by Jeff Toll with a second by C.J. Young. Motion passed. (5 in favor and none opposed.)

Spent \$27,000 on fire protection to cover township, 7 calls to the township. Have money set aside for a firetruck. EMS; came to the town 30 times, we used our leftover grant money to pay for the operational shortfall, about \$11,000. There will be discussion later about raising the tax levy to cover next year's operational shortfall estimated to be \$31,000. We donated \$1000 to the Poy Sippi Library and \$1000 to the Berlin Library. No new houses were built in the township last year. No action taken.

The 2022 Annual meeting was set for the 3rd Tuesday in April. April 19, 2022, 6:30PM at the Town Hall. C.J. Young made the motion to approve with a second from Jeff Toll. Motion passed. (5 in favor and none opposed.)

The meeting was adjourned at 7:11 p.m. after a motion by Jeff Toll and a second by Melissa Zamzow. Motion passed. (5 in favor and none opposed.)
