- B) Clerk: Will be swamped with elections from now until November. Attended an elections security training that was informational. The biggest part is reminding voters that the machines are not hooked up to the internet and their votes will not be compromised. A lot more information to learn and make sure election workers know. Must finish W-2s, the CT report is coming up.

Business:

- A) Borth Trail Twisters temp license and operators: The club is having their event on Feb. 1, 2020. Same event as last year, they have two servers that completed training, \$60 for operators and temp license. Jeff made a motion to approve the temp license and operators' licenses. Andy made a second. Motion carried.
- B) Approve Katie attending year 2 of Clerks Institute: This is the 2nd year of training, it's a week in July in Green Bay. Andy made a motion to approve Katie to attend the training. Looking at Czech Ave, but seeing as we did not receive any money from the State 90/10 program we may have to adjust projects. Andy made a motion to amend the budget with the TRIP money. Clerk, Katie Reinbold, posted the agenda on April 18 at Midway Gas and Oil, Olsen's Mill, and Town Hall board. The meeting agenda was accepted after a motion by Jeff, Andy made a second. Motion carried. The minutes of the March 12 Regular Board Meeting were approved after a motion by Jeff and a second by Andy Motion carried.

Officers Reports:

- A) Treasurer's Report: Beginning balance of \$495,225.85, deposits of \$151.57, deductions of \$340,675.94, 2 outstanding checks, cash on hand at the end of March was \$154,660.73. Jeff made a motion to approve the treasurer's report, Andy made a second. Motion carried.
- B) Clerk: Open book was April 18, 2020 from 11 a.m. 2 p.m. over the phone due to COVID-19. I have not heard how it went or if there will be anybody at BOR. Vanda Lemke will be in on either April 22 or 23 to clean the carpet. The job posting for tractor operator will be in the April 23rd edition of the Journal and Argus. It was not done sooner as I got caught up in elections. The Clerks Institute that I am attending in July has been changed from in-person to virtual. We will save money on the hotel, travel, and meal costs. The CT report needs to be completed. It was due on March 31, but we get an automatic extension to May 15. The April 7 election was a challenge. We had about 134 absentee ballots and just over 100 voters come into the polling place. It was more than I was expecting, but the people were really spread out throughout the day so that made it easier. If there were more than 7 people in the building, I would step out to keep the number between 7 and 10. April 13 we came back and counted. That went well and it took us about 2 hours to complete that. I do not know how elections will look from here on out.
- C) **Board:** Our assessor received a complaint from an individual in our township that was sent to DOR. There were a few items that the DOR reviewed with the assessor and they need to review in their office.

Business:

- A) BOR (Board of Review) Ordinances: There are a few ordinances we need to review before BOR if we want to adopt them or not. 1) Accepting telephone and written statements as testimony: C.J. does not agree with this ordinance. He feels that a BOR hearing is just as if you are standing in front of a judge. We should not allow telephone or written testimonies. The board will not be implementing this ordinance. 2) Request to waive a hearing: The board will not be implementing this ordinance as they believe everyone should go through the hearing process. 3) Alternate BOR members: The BOR should have alternates on file in case a BOR member is asked to be removed or they recuse themselves. Jeff made a motion to accept the ordinance and have Allison McCormick as an alternate BOR member. Andy made a second. Motion carried.
- B) Town credit card: Katie would like to table this item. She did not get to do a lot of research and what she did get accomplished did not get her anywhere. There is a few more avenues she would like to look into and come back to this at a different time.
- C) Approve alcohol licensing webinar for Katie on June 3: It is through the UW Extension. **Jeff made a motion to approve the training. Andy made a second. Motion carried.**
- D) Road Report: The road inspection was done differently this year due to COVID-19. Instead of the board meeting and all riding together to perform the road inspection, they did the road inspection separately when they had time. 34th Dr needs an overlay of about 200ft, the culvert at the corner of Cottonville and 31st Ave has a hole and needs to be replaced, 36th has a large pothole forming, the culvert on Riverdale is starting to collapse again, the two culverts on 36th Road appear to be caving in, potholes on Cypress Dr, 34th, Cypress Ave, 32nd Dr needs help, Cypress Ave from Hwy 49 to

32nd Dr is in bad shape with a lot of potholes. Andy made a motion to use the TRIP money for Cypress Ave. from Hwy 49 to 32nd Dr, it is not quite a mile of road, we will put down 3 in. of gravel and 2 in. of blacktop. Also, put the overlay on 34th Dr., and fix the culvert on 31st Ave. Jeff made a second. Motion carried.

A motion to approve vouchers was made by Andy, a second was made by Jeff and the motion carried. The meeting was adjourned at 8:35 p.m. after a motion by Jeff and a second by Andy. Motion carried.

Thursday May 14, 2020

Business:

- A) Interview with Robert Dick: went to heavy equipment school for 9 weeks (dozer, dump truck grader, back hoe, excavator, etc), after school went to DNR Land Conservation Department (did all the land work, huge acre wildlife center, made dykes, ran excavator, up-graded trout streams, helped up flooding and mudslides down by SE WI), looking for a little extra income. C.J. asked if the hours in the tractor would bother him and he said he could do it and would just take a break if needed; Jeff commented that it's a dirty job and Robert commented he can wear a mask if anything gets to him. Let him know what the duties of the job and the machine were.

 Interview with Pete Kallas: he did the mowing for us late last year after the Town purchased the tractor. He currently works for Young Farms in the spring and fall and would be available to cut again for the town. He likes sitting in a tractor and mowing. He used to cut ditches and roadways for the Leech company. A decision will be made at next meeting.
- B) Letter from Tavern League: The Tavern League asked we consider lowering our licensing fees due to the impact on establishments from COVID-19. Town of Aurora only has 2 establishments that must license operators and liquor. Our fees are not too high, but we understand the impact that has been. Andy made a motion to keep the liquor license fees, tobacco fees, and new operators the same, but waive the fees for current operators only. C.J. made a second. Motion carried.
- C) Road Report: Brain for the County Highway department did a bid Cypress Ave, with what is already on the road, gravel will not be needed, but the milling doubled. It would be \$105,000 for 2 in. of black top or \$175,000 for 3 in. of black top. The ditch on one side will also need to be replaced. **Andy made a motion to move forward on project with 2 in. at \$105,000, get a bid from Petrazik on ditch work and possibly replace 2 culverts. Jeff made a second. Motion carried.** C.J. got a bid on redoing the Town Hall parking lot and half of the driveway. The bid came in at \$17,500. No action on this currently. 36th Rd has a ditch issue. Trees were cleaned out a few years ago, there is a concern that the ditch is not low enough and will not be able to handle a lot of rain at one time. The culverts are in good shape. No action on this currently.

ANNUAL TOWN MEETING MINUTES APRIL 21, 2020

The annual meeting of the Town of Aurora was held at the town hall on April 21, 2020. Notices of the meeting had been posted at Midway Gas & Oil, Olsen's Mill, and Town Hall board.

The meeting was called to order at 6:34 p. m. by Chairman Young.

The minutes from the 2019 meeting were approved after a motion by Jeff Toll and a second by Allison McCormick. (5 in favor and 0 opposed.) Motion carried.

The 2019 financial report was given by Clerk Reinbold. Copies of the report had been distributed to all electors' present. It was explained that the town had a total of \$59,013.62 available to the town in all accounts on December 31, 2018. Of this amount, \$15,000 is in our contingency, and \$43,553.62 was undesignated funds. Major expenditures for 2019 included \$120,309.86 for highway repairs and improvements and \$15,896.65 for the rest of the payment for the town reassessment, \$11,175.92 went towards a new ambulance for City of Berlin, and \$59,224.00 was moved into a money cd which is for our fire truck fund, ambulance fund, and voting machines fund . Andy Pryzbyl made a motion to approve the financial report, Jeff Toll made a second. (5 in favor and 0 opposed.) Motion carried.

The road report was given by Chairman Young. In 2019, the major road projects were:

- -Stonehedge and 34th were seal coated
- -Culverts replaced on Cumberland, 36th, and 34th
- -Overlavs were done on 32nd Dr, Cypress Ave, and 36th Ct
- -Spent \$48,000 on snowplowing
- -Also bought a tractor and mower for roadside mowing No action taken.

Discussion of salaries, the mileage rate is the number the state uses; . Road patching is at \$13.50/hour plus mileage and Andy Pryzbyl is planning on continuing that. Mowing for the town hall and Sacramento cemetery is \$15/hour (if you use your own mower) plus mileage. Gordy Pryzbyl will still do the mowing. Roadside mowing operator will be \$12/hour. Still looking for someone to do the roadside mowing. Election inspectors are at \$10/hour and chief inspectors are at \$12/hour. Chairman wages are at \$5,000, supervisors are at \$2,750, treasurer is at \$5,000, and clerk is at \$10,000. Katie would like to go up by \$2,000. Everyone else is fine with wage amount. C.J. thinks that Katie wanting to go up is acceptable and that \$1,000 will come from the road budget and \$1,000 will be taken from his wages. Jeff and Andy do not agree that C.J.'s wages should go down by \$1,000. He takes the brunt of the phone calls and has a good relationship with the county highway department. Andy made a motion to keep all wages as is expect for the clerk that will now be at \$12,000. Jeff made a second. Motion passed. (5 in favor and none opposed.)

Tax levy should have been removed from the agenda. This is not the appropriate time to discuss the levy. That is done in the fall with budget discussions.

Town posting locations were discussed. Currently the clerk posts notices at Midway Gas, Olsen's Mill, and the Town Hall and on the Town website; www.townaurora.com. Also, the required newspaper notices are being put in the Waushara Argus. A motion to approve keep the posting locations as is was made by C.J. Young with a second by Andy Przybyl. Motion passed. (5 in favor and none opposed.)

Beer, wine and liquor licenses were discussed. Liquor license is \$150, beer is \$100, wine is \$100, one day beer license is \$10, and cigarette is \$20. A motion to keep them the same was made by Jeff Toll with a second by Katie Reinbold. Motion passed. (5 in favor and none opposed.)
